

Rules of procedure for the 1st edition of the family contest *My nationality and culture in Krakow*

1. The organiser of *the My Nationality and culture in Krakow competition* is Maple Bear Schools Polska P.S.A.
2. Objectives of the competition:
 - (a) appreciating the diversity of cultures and nationalities in the city of Krakow;
 - (b) building an attitude of respect towards people of different nationalities;
 - (c) intercultural integration;
 - (d) stimulating and developing artistic activity through the creative interpretation of the subject;
 - (e) presenting the creativity of children, young people, and families.

Rules of participation in the competition:

1. The competition is intended for children between 3 and 18 years of age.
2. Participation in the competition is voluntary and free of charge.
3. The application for the competition can be filled out using the form available on the following website: www.maplebear.pl/konkurs Mail: p.kundera@mbkrakow.pl tel.: +48 607 051 268 until May 17, 2024.
4. The child shall enter the competition after his/her parents/legal guardians have signed the statements attached (Annexes 2 and 3) and provide it along with their entry for the competition by 24 May 2024.
5. The subject of the competition: *“My nationality and culture in Krakow”*.
The task of the participants will be to prepare artwork showing their nationality or culture in Krakow.
 - **Technique:**
any; flat work (e.g. painting, drawing, collage, photomonting, computer graphics, etc.)
 - **Format:**
A3 or A4
6. Competition (art) work will be assessed in the following categories:
 - Preschool children (3-6 years) with parents
 - Children aged 7-10
 - Children aged 11-14
 - Adolescents aged 15-18
7. The selection board will take into account the compliance with the subject of the competition and the interesting form of expression, as well as the overall aesthetic impression.

8. The works submitted to the competition will be transferred as property of the Organizer. Each work must be accompanied by a **metric** with a signed declaration by the parents/legal guardians (Annex 1).

9. The deadline for delivering works, metrics and statements by parents/legal guardians/participants to the organisers address is **24 May 2024**.
